If your reading this letter RIGHT NOW THEN YOU PROBABLY ALREADY KNOW BY NOW WHAT HAS TAKEN PLACE. LISTEN MAN, PLEASE MAKE SURE THAT MY DAUGHTER GETS ALL MY PROPERTY IN MY CELL. THERE IS SOME BOOKS AND A WISHING WELL THAT GO TO MY MOTHER AND SISTER MARION. I COULD NOT TAKE THE HEAD GAMES OF PRISON OFFICIALS ANY MORE. THEY HAVE BEGUN A NEW POLICY WHICH NOW INVADES THE MOST BASIC PRIVACY RIGHT WE HAD WHICH WAS BEING ABLE TO SEND OUT OUR MAIL SEALED. NOW ALL OUR PERSONAL LETTERS MUST BE MAILED OUT OPEN FOR STAFF TO GO THROUGH. WE HAVE A PRISON FULL OF HATEFUL, RACIST STAFF WHO MESS WITH OUR MAIL, FOOD AND MINDS ANYWAY - NOW THESE PEOPLE WANT TO INVASE OUR ONLY MEANS OF PRIVACY TO THE OUTSIDE WORLD. I CAN'T DEAL WITH THAT. PLEASE LET MY POU PALS KNOW THAT I LOVE THEM FOR BEING MY FRIENDS AND GIVING ME THE SUPPORT I NEEDED TO MAKE IT THIS FAR BUT I WILL NOT ALLOW THEIR PRIVACY OR MINE TO BE VIOLATED BY

nosey uneducated Guards who are hateful. we have Guards like this one on second shift named MASON who goes out of his way to harass Dean Row - when I complained to Lt: MANN he done nothing about it but put the guard working our side (EAST) of the Row. we cant get group REC no more - we have no exercise equipment not even an ab wheel to use. The Guards always play games to cheat us out of outdoor REC.

They wont pass out coats to everyone like we had before. now everyone has to wear the same coat which is a health issue because everyones hygiene isnt the best. because of our dumb ASS Governor and Commissioner we have all this privatized shit like ARAMARK food who always shorts us on things like biscuits we get one instead of two or no sugar for our cereal, cold food, one cookie instead of two - THE menu calls for all this but thanks to "cut back mitch" our medication has been cut or replaced

because they want everyone on the same
"formulated" meds they want to pay for.
we have no redress in the courts
because the Judges let prisons treat

a unit manager in charge of death row

murdered. He has taken special interest

and will not continue to be treated like
this. my visits have been taken for
NO REASON AT ALL AND I CANT VISIT
with friends like other people on
the row because of Cecil K. Davis.
Im always treated different m. sticer
and i cant take it no more. if these
people Aint stopped soon more lawyers
will lose clients. This mail shit is
the final straw for me. Im sending
you a list - please make sure my daughter
gets all my things. i have one bag for
my sister marion and one gift to my
mom. please call Julie Carter (Lari)
and notify her so she will claim my
body for me. I have her listed as
next of kin.

I don't want my family claiming my body. Cari promised me she'd do it for me to make sure i was buried out of INDIANA. Please Release this letter to the media so they will know that stress brought on by all the ABOVE mentioned things caused me to check out early. besides that im tired of getting close to these guys in here and then watch them slowly crack as they near their fate. THATS worse then a death sentence. Also i wanted the electric chair not the needle. so in a sense i had the final say so. to all my friends and pen pals who were there for me, i love you all. to my daughter and granddaughter im sorry for the pain i love you both but i couldn't go on after this mail policy.

PLEASE SEE THAT THE PRISON HONORS MY LAST WILL & TESTAMENT
